2024 WINTER INTERSCHOOL SPORT COMPETITION

Congratulations on your child's efforts in being selected to represent Gilston State School in the Winter Interschool Sport Competition commencing Friday 19 April 2024. Children will be transported by bus to and from various venues throughout the season. The draw will be available each week on the school website (www.gilstonss.eq.edu.au). The website will also be updated with any sporting information including any cancellations.

All children are required to pay a season levy of **\$80.00** which will cover all bus fees, and district sport levy. The season will run for 8 weeks finishing on Friday 7 June 2024. The full payment is **due by 10:00am Friday 12 April 2024.** It is our school expectation that your child will participate in one of the sports offered to develop both physical and social skills.

Payment can be made at any time via QParents, BPoint or the internet until Friday 12 April 2024; please use your students EQ ID and **SPORT** as the reference/description. **Bank details are BSB 064 468, account no 10012085.** Payment window is open Thursday and Friday 8:00am to 10:00am.

During winter sport, all students will be provided with a sporting shirt/jersey for their sport. This must be washed each week and returned at season's end. GSS Football socks can be purchased from the Tuckshop at a cost of \$14.00. These are required for Soccer and Rugby League.

Mouth guards are compulsory in 2024 for Rugby League. If your student does not bring the mouth guard for game day they will be unable to take the field. This is a State-wide EO mandatory requirement.

Please make sure that your child attends their training sessions, as it is important to develop skills and run through game strategies. Training will be held no matter what the weather, if it is wet there will be an undercover session held. A drink bottle and hat should be brought to these training sessions. If a child is training before school it would also be advisable that they bring another t-shirt to train in.
